Maureen O'Connor, Chief Justice of the Ohio Supreme Court, reports that 25% of voters casting ballots for elected officials do not vote for judges. Why is this? And what are the consequences? Because persons running for judge are not listed according to party affiliation, it may result in the role of the judiciary being minimized in the voter's mind. This is a false assumption we must guard against.

Our democratic system of government is based on a three-part model of checks and balances. Where are the people to turn when the Executive branch is hamstrung, and the Legislative branch refuses to operate cooperatively? It is the Judiciary that mediates. Its job is to compare laws passed by congress (both Federal and State), and executive- actions produced by a given administration, with the Constitution and with established practice. It determines whether corporations and agencies are acting according to acceptable standards and protecting the life, liberty and pursuit of happiness guaranteed the citizens of the nation.

The State Supreme Court is our state's court of last resort. It consists of a panel of elected judges and is completely distinct from the United States federal courts - whose judges we, the people, are not able to choose. In this time of political extremism, when so many of our legislators are unwilling, or unable, to work for the people, multiple issues affecting us are finding their way into the courts. These issues are farreaching and impact many facets of our lives. They include voting requirements, polling locations and hours of operation, civil rights, protection from environmental hazards, workplace safety – and so much more.

The role of the Judiciary cannot be minimized: VOTE!

# Tom Letson, Justice of the Supreme Court

State Representative Tom Letson (D - Warren) of the 64<sup>th</sup> District is a fourth term lawmaker who is proud to serve his neighbors in parts of Trumbull County.

Multiple medical studies - many conducted in Cincinnati – have examined the effects of toxic materials found in coal ash and the chemicals used to produce energy from coal. There is virtually no price to be paid for genocide-by-toxic-waste. Corporations have all the rights and privileges of citizens, but none of the accountability. All a corporation in serious trouble has to do is "die" (go bankrupt) and reemerge as a new being. As Robert Kennedy Jr., president of Waterkeeper Alliance explains: the poisoning of the American people reveals "a critical systemic political problem": industries are so powerful they subvert the democratic process. What will it take to inspire us to read "the signs of the times?" Coal-burning power plants provide us with heat, cooling, light and JOBS. But what will make us open our eyes to the hidden costs we pay for our imagined safety and comfort? Why do we dismiss and ridicule the alternatives? There is so much to be gained by supporting clean, renewable energies.

Let's consider some facts. Mother Jones magazine, (Sept.-Oct. 2014), reports on the following information provided by the International Energy Agency (IEA). Every 104 minutes enough sunlight shines on the earth to provide the whole world with power for a year. The U.S. has the means, the space and the sunlight to produce 100 times its need for usable, clean energy. Worldwide, power generated by solar installations has grown, on average, 66% a year since the mid 2000's. Solar industry jobs have increased 50% since 2010. Solar workers OUTNUMBER coal miners nearly 2 to 1. Jobs in clean, renewable energy industries are outgrowing other job opportunities! Europe knows this. China knows this. The average cost of solar panels in 1972 was \$75. (DOLLARS) per watt. Because of their foresight and commitment, the expected cost of Chinese panels in 2015 is \$0.42 (CENTS) per watt!

In 2014 there have been three major toxic spill events east of the Mississippi. Chemicals used in processing coal have leaked into the Elk River in West Virginia and 100,000 gallons of coal slurry leaked into Fields Creek in McDowell County, WV, making its way into the Kanawha River and polluting the Kanawha watershed. Also, an 80,000 ton pile of coal ash has collapsed into the Dan River in North Carolina.

Contradictory and ineffectual messages about water safety, given to the people by their leaders and

environmental officials, are being broadcast. People are afraid to drink, bathe in or breathe vapor from their tap water. The Federal government has issued over 20 subpoenas in NC, alone, to investigate how the state and its governor, a retired executive of Duke Energy, have interfered in North Carolina's environmental protection responsibilities.

What will it take to break through the denial system of the average American trying to live a reasonable and ethical life in a world so endangered? We are as addicted to our denial as the addict is to heroin. What will it take to empower us to abstain? Hitting bottom? We have nature's remedy for challenging denial unfolding before us: cumulative toxic spills and accidents that can serve to awaken us to the fact we are being poisoned. Will we learn? What have the byproducts of burning coal been doing to us – to our families? And as we watch what is unfolding in our neighboring states, do we ask ourselves what will we do when it happens here? What is our contingency plan when the tons of coal ash on our southern border collapse into the Ohio River? - When the toxic materials stockpiled in the county reach the watershed? But there is more to be lost than our health - our bodies. Denial weakens our ability to think critically - to "connect the dots". Denial poisons the soul.

How is it that so many Americans cannot read the signs of the times? How can it be that China - a country that ignores human rights and restricts internet access for its people – is helping to reduce the scourges of cancer, neurological damage, asthma and so much more? Are the Chinese simply driven by profit motive and see the future more clearly? Do they care more for their people? Do they have more insight than Americans? More initiative? Are we so badly addicted to the "comforts" of denial that we will be left dying – clueless - in the dust? What are we waiting for? The average man votes below himself; he votes with half a mind or a hundredth of one. A man ought to vote with the whole of himself, as he worships or gets married. A man ought to vote with his head and his heart, his soul and stomach, his eye for faces and his ear for music; also (when sufficiently provoked) with his hands and feet. If he has ever seen a fine sunset, the crimson color of it should creep into his vote. The question is not so much whether only a minority of the electorate votes. The point is that only a minority of the voter votes. Gilbert K. Chesterton



Registration forms must be delivered to the Board of Elections by the end of the business day on October 6, 2014. If mailed, it must be postmarked no later than October 6, 2014.


