There is little doubt America seems to be choosing Joe Biden to win the presidency in November. This makes my heart happy but concerns me about the price to be paid for what we have tolerated for years – both nationally and locally. On a broad scale, history has shown us what happens when life catches up to a malignant paradigm. Individuals unravel. Hateful defenses increase. Some resort to drugs, to suicide – some try to take the whole world down with

them. A people, a community, such as ours, that has tolerated injustice for years, that has persistently refused to diversify in multiple areas, find themselves facing a time of transition comparable to the transition from the Dark/Middle Ages to the Age of Industrialization, Science and Technology. While we agonize over the political implications of wearing masks and increased discomfort in the presence of one another, Adams County walks a financial tightrope with 1/3 less revenue and reduced capacity to keep up with basic community necessities, such as

policing. We are far from being ahead of the curve being delivered by Corona. After initially downplaying the danger of COVID-19, our Health Department now officially stands behind an underestimated number of virus-related deaths - while obituaries have doubled and tripled since winter. We are on the brink of more than an election. We are, collectively, moving from one historical age to another. "Normal" is being redefined. We will not simply be "getting back to

normal". All of our old assumptions – and the behaviors we took for granted - are falling away. "Normal" is being reforged. Some see horrendous pitfalls as well as wondrous opportunities ahead.

We have tolerated tensions between political parties in Adams County for a very long time. When I first moved here I wanted a yard sign during the Kerry campaign and

went to the Board of Elections to ask where Democratic headquarters was. I went into

the wrong office and the two women behind a counter looked at me with contempt. I was a "sub-person" to them and they managed to get it across to me without speaking a word. Since then I've known many Dems who think we keep the peace by refusing to confront political prejudice. Now, however, it's reached a new octave. Now we are

in free-fall through Alice's looking glass.

This first became viscerally clear to me last autumn. I turned onto a road ½ mile from the center of town and misjudged how fast a car heading toward me was speeding. The car raced by me and in my rear-view mirror, I saw it make a screeching cops-and-robbers 180-degree turn and follow me into town. I pulled into the Marathon Station and the car pulled up next to me. The window lowered. The car was black and the driver was dressed in black with

a black scarf on this head and sunglasses. He was slender

and appeared to be young enough to be in high school. He snarled and accused me of cutting him off. I told him I know I did, and I didn't mean to and that I was sorry - but that I hadn't realized how fast he was going. It escalated. He said it was my fault – that I nearly made him crash. I said it was his fault, too, because he was going about 70mph in a 25 mph zone. Then he said, with extraordinary contempt in his voice: "You're a Liberal, aren't you?" I asked him what he was talking about. He said, "You're a Liberal, you talk like a Liberal." This continued until I told him he was trying to threaten me and I was writing down his license number. He took off. It felt like an omen – and it was. One thing was clarified for me at that time: being a liberal means we are



both responsible – and liberal-haters find responsibility intolerable.

Then came COVID-19 – and contempt has moved into a higher gear. I have many local examples. Here are a few. (1) My friend, wearing her mask, got out of her car to pick up medicine for her dog at Dr. Bailey's. A man pulled off the road, got out of his car, and accosted her: "Why are you wearing a mask? Are you a member of ANTIFA?" She told me the shock made her think of my "man-in-black". (2) A nurse working in a nursing home told me there really is no pandemic. She said COVID was a lie invented to keep people out of church so they forget God. (3) A local builder told me children are being kidnapped and tortured to make their glands produce a substance that is used as medicine to keep a cabal of certain evil men in power. (4) I was told by a cashier in a local business that "we're being watched all the time" - that some birds are really drones - especially the ones that hit windows. She said COVID-19 was invented

to keep us indoors so we won't see them "change the batteries in the birds". On a nationwide scale, a group called "Q-Anon" (think Tea Party out of the closet, psychotic, and on steroids) has over a million people interacting on Facebook. They believe that Democrats, along with "Hollywood Elites" and Jews, traffic children and eat human flesh. They believe Trump is on to this and his tweets – filled with misspellings and capitalizations – are really hidden messages telling his followers he will soon round us up and send us to Guantanamo for execution. They hope to speed up his agenda by instigating violence during peaceful demonstrations.

This madness is not without meaning. With the increased

speed of data moving through the internet and increased use of virtual communication platforms, such as Zoom, anxiety is increasing. Many of us are getting hints of the mind-blowing changes in store for us. I think it is critical for us in Adams County Ohio – along with our counterparts in other places, rural and urban - to ask ourselves: How have we contributed to this madness? How do we feed it, support it - every day? Why have we repeatedly failed to speak up before it got so out of control? Over the last few years, some people have told me they are afraid to be associated with a number of themes I've raised in letters to the editor in the Defender – not because they disagree with me, but because they don't want others "to know" their names or what they think. Most of those who have called me are unable to articulate what it is they are so afraid of. The phone calls have stopped because I don't have a landline anymore – but those conflicted people (our neighbors, known and unknown) are still out there - each feeling alone. And we, Democrats, have failed to rise to meet this crisis because we, too, are afraid

and have opted out. Years ago I was told by a fellow Democrat: "You people from New York don't know the trouble you can stir up around here." Message: "keep a low profile or you'll make things worse – you'll make MY life worse."

This timid life-view disempowers us for what's ahead. A few weeks ago a man bush hogged my field after I ignored it for 3 years. It took longer than a day and when I paid him he said (out of the blue and in all humility) there was no way a machine could be made to do what he did. What struck me about the conversation wasn't his conclusion – but the fact he was THINKING about it – about computerized machines replacing us. And I know he – along with the rest of us – never thought we would get to witness this rapid transition into a new historical age. The definitions of life and work are being rewritten. Corona has speeded up our increasing reliance on virtual money, work, communications, medical services, leisure activity, and education. Artificial Intelligence/virtual reality is ramping up to run the show. Mankind sees

itself on the brink of becoming superfluous – unnecessary – to life on Planet Earth.

Love radiates out from Joe Biden's spirit in his warmth and sincerity. And unflinching courage seems to radiate from Kamala Harris. These two may be the very models we need at this critical time. But models are wasted if we fail to tap those qualities in ourselves. The WHOLE of love, its active as well as its passive side, is necessary. Passively loving our neighbor to avoid stirring up trouble will not get us through what's ahead. A rapid transition from one historical age to

another is upon us. It's more than a revolution in politics, economics, and healthcare that's ahead. It's a revolution in the very nature of life and work on planet earth. Human life is being recalibrated. We need to support one another to weather the fact that life will not be going back to "normal". We need courage to stand firm in a world run by Artificial Intelligence – a world that is rewriting the meaning of human life on planet earth. A wise Adams County Democrat once said to me: "How are we going to grow the Party if we don't grow a heart?" She meant more than a warm and all-inclusive heart. She also meant courage - the heart of a LION. •

We live in an era when fake news is real and troubling. Half-truths and outright lies run rampant from many politicians and on social media platforms. Such propaganda is released to purposely mislead and manipulate the voting public. As citizens, we often must wade through the weeds to separate fact from fiction and to just get to the truth. Here are some internet resources to help folks determine whether claims and accusations in the news are true or false.

FactCheck.org

This nonpartisan, nonprofit organization monitors the veracity of what is said by politicians, TV ads, debates, interviews, news releases, etc.

MediaMatters.org

This nonprofit research center, which describes itself as liberalleaning, monitors and corrects misinformation in the media.

OpenSecrets.org

This nonpartisan and nonprofit website, run by the Center for Responsive Politics, tracks how much and from where politicians get their campaign funds.

PolitiFact.com

This Pulitzer Prize-winning website rates the accuracy of claims by elected officials. It features the Truth-O-Meter, which rates information as "True," "Mostly True," "Half

True," "False," and "Pants on Fire."

ProPublica.org

This independent, nonprofit newsroom has won several Pulitzer Prizes. ProPublica produces investigative journalism in the public interest.

Snopes.com

This nonpartisan website researches urban legends and other rumors. It is often the first to set the record straight on news claims that seem wild and far-fetched.

Sunlightfoundation.com

This nonpartisan, nonprofit organization uses public policy data-based journalism to make politics more transparent and accountable.

Washingtonpost.com/news/fact-checker

This is the Washington Post's fact check feature. Although the publication has a left-center bias, its fact checks are excellent and well-referenced.

These are just some of the websites which have emerged over the past decade to promote truth and transparency in our politics. Because fake news is real, and dishonesty and corruption are all too common, it takes time and effort to get the straight scoop. Fortunately, the above types of tools are now available to help us be well-informed voters. •

GOP Politics as Usual?

Lise lots of misinformation and outright lies posted on social media. I have seen posts "shared" by folks where it appeared they simply looked at the sensational headline and didn't take time to read the article. Is this intentional and meant to mislead, or are some folks just too lazy to read the entire article, or heaven forbid, actually fact check and research to see if it is true? Regardless of the intent, the effect can confuse and spread false or misinformation.

One "meme" circulating shows a chart with two headings side by side labeled Democratic and Republican with the most extreme and exaggerated positions listed under Democratic. Of course, under the Republican side, the position stated appears either more reasonable or, in some cases, plays on prejudices and fear. I want to examine further one of those items. According to the "meme", Democrats are for BIG Government, and Republicans are for LIMITED Government. Really?

What do they mean by limited? Limited to serving the haves or the top 10%? Or do they mean limited to serving themselves and their families? Here's an example at the national level. Look at Mitch McConnell, a man who has spent his career on the public payroll. He is now wealthy. Is that due to sound investments of his public salary, or due to

gifts from his Chinese in-laws? His 2 nd wife, Elaine Chao, is currently Secretary of Transportation and on the public payroll too.

Recent headlines and FBI investigations show that corruption is rampant in Ohio's GOP. In 2016, the local GOP chose to appoint a sitting Commissioner, Brian Baldridge, to run for an open seat. Was this illegal? No, but a maneuver that allowed Mr. Baldridge to pocket a hefty pay raise and then run for State Representative in two years from a protected position. In 2018, Mr. Baldridge ran in the Republican Primary and, he was supported financially by what has been referred to as "Team Householder." He was elected, and yes, he voted for HB6 to bail out a couple of nuclear

power plants. This bailout didn't help the Stewart or Killen power plants in Adams County. What did his constituents get out of this deal? Nothing. However, his wife, who had been employed by the corrupt and now-defunct Electronic Classroom of Tomorrow (ECOT), now has a state job with the Secretary of State's office as Field Liaison for Southeast Ohio. Ah, two in the family on the public payroll. The sponsor of HB6 was Shane Wilkin, and recently, his wife, Kristy, was appointed Judge 4 th Court of Appeals. Another twofer and beneficiary of Team Householder!

Speaking of Team Householder, I want to know if the corruption and influence are limited to members of the legislature who helped pass HB6 and elect Mr. Householder as Speaker, or did this money and influence reach further? We certainly know from campaign finance reports who received campaign contributions from Team Householder. Do we know who else benefited or if money was given to individuals personally? 60 million dollars is a lot of money, and it would be interesting to know where every dollar went. The Treasurer of the Adams County Republican Central Committee, Stephen Caraway, was affiliated with Mr. Householder as his Candidate Recruiter & Campaign Advisor. As such, perhaps he could shed some light on where the money went

or where it is still going.



Joe Biden Will Bring Back a Trait Lacking in the White House... Empathy.


Residents of Adams County, Ohio, know what it's like to work hard day in and day out and still struggle to get ahead. We have seen jobs disappear, and poverty rise. According to a report in the Highland County Press and data from the U.S Census Bureau; Adams County is the poorest of Ohio's 88 counties with a median income of \$36,320, a poverty rate of 23.8%, an unemployment rate of 6.5%, and the population decreased by 2.1%. These staggering numbers are from before the



Joe Biden was born in the blue-collar city of Scranton, PA and was the son of a father who had suffered many financial setbacks. For several years, his family lived with grandparents, and when it was clear that Scranton was not going to have an economic recovery, the family moved to Delaware. Joe Biden often recalls the story of when his father informed him that he needed "to be strong" because he had once again lost his job. Joe knows what it is like for families to struggle and to be one paycheck away from losing everything. While Vice President, he was in charge of oversight for the American Recovery and Reinvestment Act of 2009 and brought the United States out of the worst economic disaster since the Great Depression. thy for victims of domestic violence.

CoVid19 deaths have surpassed 185,000 in just a few short months, and thousands of families are mourning for their fallen loved ones. 

Voting Information

Remember, the deadline for voter registration is Monday, October 5. You can complete this process by filling out a Voter Registration Form, available online or from Adams County's Board of Elections, 215 N. Cross St., West Union, OH 45693. The form can be completed online, mailed in, or returned in person anytime before 4 p.m. on Monday, October 5, 2020.

Voters have choices this year... beyond the obvious, "Who do I want to vote for?" Mostly it amounts to "How do I want to vote?" and "When do I want to vote?"

In-person Voting As always registered voters can go to the polls on Election Day (Tuesday, November 3). Trained members from both of the major parties are available to help – if there is a question concerning the voting machines; if a paper ballot is wanted; if you need to vote from your vehicle; or, if for some reason, you need to cast a provisional ballot.

It will also be possible to vote in person using equipment set up at the Board of Elections in the Courthouse Annex. This is referred to as "Early In-Person Voting" and the calendar below indicates when the polls will be open (note there are some late nights and weekends) beginning Tuesday, October 6. Just like on Election Day, trained members of each party will be available to assist if you have questions or encounter difficulty using the voting machines.

Absentee Voting In Ohio any registered voter can request an absentee ballot for any reason. If you decide to take advantage of this option: you will need to complete and return the application indicating that you would like to vote absentee in the November 3 General Election. You will not have to declare your party affiliation.

Absentee ballot requests are available online (https://www.boe.ohio.gov/adams/absentee-information), at the Board of Elections, or by calling the Board (937 544-2633). It's most efficient to return a completed application in person or to mail it to the Board. Once an application has been processed, the Board of Elections will mail out the actual absentee ballot (beginning on Tuesday, October 6, 2020).

Once a voter receives an absentee ballot, he or she can fill it out at home, then return it in person to the Board of Elections (there's a locked

"dropbox" located outside that office, just in case the office itself is closed) or the ballot can also be sent in by mail. The ballot must be postmarked no later than Monday, November 2, 2020. However, it is suggested that voters might wish to mail-in absentee ballots no later than Monday, October 19, or bring them into the Board of Elections – so they arrive before 7:30 p.m. on Election Day.

It is important to consider that once you've requested an absentee ballot, you will be asked to cast a provisional ballot if you decide to vote in person. Each provisional ballot will be counted (starting the day after the election), once it's been determined that there is no record of another vote cast by the same individual – either by absentee ballot, via early voting, or at the polls.

Final Checklist Common mistakes that cause delays (or may invalidate an application or ballot) are (1) lack a signature, (2) omitting date of birth, &/or (3) not supplying the last four digits of a Social Security Number or a driver's license number. With that said, however, you decide to do it, make sure you vote ... our nation and our democracy are depending on it. ❖
