Candidates for Justice Ohio Supreme Court

In 2020 there are two seats up for election for Justice of the Ohio Supreme Court. We have two qualified candidates running for these two seats, Judge Jennifer Brunner and Judge John P. O'Donnell.

Judge Jennifer Brunner for Ohio Supreme Court

Judge Jennifer Brunner serves as one of 8 state appeals court judges of the Tenth District Court of Appeals located in Franklin County, Ohio; she previ-

ously served in elective office as a Common Pleas Judge (2000-2005) and Ohio Secretary of State (2007-2011). In 2008 she received the bipartisan John F. Kennedy Profile in Courage Award for her public service. Previously, she

was a principal at Brunner Quinn just prior to being elected to her current judicial position in 2014 and reelected in 2016. Having founded her law firm in 1988, Judge Brunner holds 17 years of private law practice experience as well as state government experience in the Ohio Senate and

the Secretary of State's office as a staff attorney.

Judge Brunner has been married since 1978 to attorney Rick Brunner. They have three adult children and five grandchildren. Born in Springfield, Ohio, she has spent her formative and adult years in Columbus, Ohio, graduating from Columbus public schools, from college at Miami University of Ohio, cum laude, and from law school at Capital University Law School with honors.

Judge John P. O'Donnell for the Ohio Supreme Court

Tudge John P. O'Donnell is running for Associate **J** Justice of the Ohio Supreme Court. John currently serves on the Cuyahoga County Court of Common Pleas. He was first elected in 2002, and then again in 2006 and 2012. The Cuyahoga County court is one of Ohio's busiest, and during that time Judge O'Donnell presided over scores of jury trials in felony criminal cases and civil lawsuits. In 2008, Judge O'Donnell was selected by the chief justice of the Ohio Supreme Court to be one of only eight trial court judges in the state to preside over a commercial docket devoted strictly to business litigation. He has been responsible for over 2,000 commercial cases while still handling all other varieties of civil lawsuits and a felony criminal docket. He is the author of over one hundred judicial opinions.

Judge O'Donnell attended St. Joseph High School

in Cleveland, Miami University in Oxford, and Cleveland-Marshall College of Law. Judge O'Donnell has served on the boards of several Northeast Ohio non-profit organizations. He and his wife are raising five children in Lakewood.

 the candidate's name. Only votes cast for candidates who filed as a write-in will be counted. Do not write in a
 candidate's name if that person's name already is printed on the ballot for the same contest.
- If you make a mistake or want to change your vote: return your ballot to an election official and get a new ballot. You may ask for a new ballot up to two times.
