FOLLOW THE MONEY

Have you ever thought that money rules politics? Maybe you think that political parties are the main source of money for candidates, but you would be wrong. Political Parties are actually regulated as to how much money they can contribute to state and federal candidates. However, some groups aren't regulated. Two groups that contribute to campaigns and aren't subject to the same limits are political action committees (PACs) and 501c4 organizations. You likely have heard the term Dark Money and wondered what it meant. Dark Money refers to political spending meant to influence the decision of a voter, where the donor is not disclosed, and the source of the money is unknown. Dark Money can refer to funds spent by a political nonprofit or a super PAC.

On July 16, 2018, the US Treasury Department made it even easier for elections to be influenced by "Dark Money" when it ruled that 501c4 groups did not have to report its donors to the IRS. Groups such as AARP and the NRA can give to campaigns and run ads without revealing the source of the funding.

A Common Cause spokesperson said that Americans for Prosperity (AFP) founded by the Koch brothers, has been fighting for this IRS change for years. AFP has been the most active and visible advocate for reducing and preventing disclosure of donors to 501c4 organizations. Elections do have consequences.

It is quite interesting to examine the campaign finance reports filed with the Secretary of State. You can see the contributions made by PACS, both political and corporate, as well as the individuals who support a candidate. Sometimes reviewing a campaign finance report paints a picture of who a candidate may be "beholden" to or what special interests they will support. Check it out for yourself and be sure to go beyond the 1st page to "follow the money"!

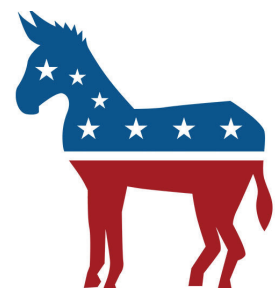

ECONOMICS PART III

We have fallen through the looking glass into the age of predatory economics. Mega-corporations, not individuals, determine livelihoods as well as all the “rules of the road” for economic conduct. The meaning of ethics has been revamped. The Supreme Court has decided a corporation has all the rights – but not the responsibilities – of a human being. As a result, since a corporation doesn’t have a soul or a moral life, business decisions substitute for ethical decisions. Corporate duty is to its corporate entity, not to its individual workers or customers, or to mankind at large, or to the very earth – which it exploits and poisons for profit. Cost-benefit analyses become moral lenses. Corporate ethics have produced monsters, such as the Challenger explosion, the exploding Ford Pinto, refreshing, mint-flavored cigarettes and safe, easily available opioid pain medications.

A healthy, educated middle class has the knowledge and the power to restrain corporate excesses, so the middle class is targeted for extinction. Debt is centrally involved in the destruction of the middle class. Debt is a by-product of our economic philosophy and is central to our economic system. It is the means by which the rich get richer and the poor, poorer while the industrial system converts from human workers to robots. Pay Day Lending is a useful tool for greasing the wheels for the destruction of the middle class. It is a byproduct of an ongoing manipulation and erosion of the economic system that supported industrialization for more than a hundred years.

A Pay Day Loan (PDL) is a relatively small high-cost loan, usually due in 2 weeks and made with a borrower’s post-dated check or access to his bank account as collateral. The annual percentage rate is extremely high. It is designed to trap borrowers in debt. In Ohio, there are more than 650 PDL storefronts in 76 counties. According to the Pew Charitable Trust, payday lenders in Ohio charge the highest interest rates in the United States, with a typical annual percentage rate (APR) of 591%.

Who needs Pay Day Loans? They are varied, but, mostly, the working poor. They can be

people who get laid off or are employed full-time but cannot make ends meet. They can be people who manage the little money they have poorly. They can be people who are addicts or who have other costly addictions. They can be people whose household has 2 working parents whose Dad works on the roads during the day and McDonald’s at night, and whose Mom is an attendant in a nursing facility who works two and three double shifts a week. They are people who are exhausted and desperate. It is estimated that 1 in 10 people in Ohio has used Pay Day Lending.

Some groups purporting to “reform” the system, such as the Ohio Consumers Lenders Association, in fact, provide funding to lobby for the continuation of Pay Day Loan practices. In actions worthy of inclusion in the novels of George Orwell, they paved the way for Pay Day Loaners to obtain licenses through a loophole in a 2008 Ohio law. This allowed them to operate as “credit service organizations.” This is an

ongoing effort to support the exploitation and destruction of the remnants of the American middle class.

While some other states, such as New York, banned Pay Day Lending long ago, Ohio has resisted changes in Pay Day Lending for years. Finally, with elections looming and the prospect that our Governor may be running for president in the future, John Kasich signed a Pay Day Loan law only weeks ago. He appears to be beginning his campaign with claims that his plan could become a model for the

nation. He recommends what Democrats have been lobbying for, such as setting specific limits on fees and interest rates and prohibiting the use of vehicle registration as collateral. He has signed it into law, but some legislators are fighting it. They claim it is unconstitutional on the grounds it proposes to regulate what private businesses should be able to offer to the public – or perhaps better said – DO to the public.

NOW IS THE TIME: PUT PEOPLE FIRST IN OHIO

You probably have heard talk that it is past time to purge the Ohio Statehouse of corruption. We agree! In recent years, there have been too many shady dealings and too much outright theft from tax-paid funds. And there have been way too many power dynamics, with profits given higher priority than people. Here are some examples of negligent and corrupt government during recent years of Republican rule in Columbus.

• **Wage Theft** - Thousands upon thousands of Ohio’s hardest working and most thinly stretched workers have been raked over by minimum wage violations. Studies show that unchecked wage theft has led to \$600 million lost each year from shorted paychecks to Ohio’s workers. The state has all but abandoned its role in enforcing laws to protect workers from this type of abuse. Ohio holds the dishonor of rating second in the nation for its negligence in this area.

• **Police Officers Denied Safety Equipment** - We all know that Ohio’s police officers have extremely dangerous jobs. The State of Ohio has needlessly


put our peace officers at heightened risk by not replacing expired safety equipment, such as body armor and bulletproof vests, in a timely fashion. Yet, Ohio’s Attorney General, who currently is the Republican candidate for governor, has always had uninterrupted access to his very own operational, bulletproof vest!

• **Predatory Lending** - Ohio’s inadequate regulation and oversight of payday loans and title loans has led to an investigation by the Federal Bureau of Investigation (FBI). This investigation recently prompted the resignation of the now-former Republican Speaker of the House. He and his office are at the center of this very serious investigation. Predatory lending practices hit Ohio’s most thinly stretched citizens harder than anyone else.

• **Chartergate** - This is a scandal nearly twenty years in the making. It involves gross misuse of millions upon millions of public dollars by private businesses and “charter schools,” which have inadequately delivered on their promises to educate Ohio’s children. Here in Adams County, in

the last two years alone, nearly \$2,000,000 have been siphoned away from public schools for this failed experiment. When our current Ohio Auditor should have been checking these charter schools' books, he was instead speaking at their meetings and accepting campaign donations from them. And, the Attorney General, who now is the current Republican candidate for governor, also has accepted cash campaign contributions from charter school operators.

• **Human Trafficking** - This is a painfully ugly truth that refers to the illegal, outright misuse of fellow human beings for free labor and/or sexual exploit. Ohio has the dubious distinction of ranking 4th in the nation for the frequency of this scourge here in our state. If this problem is to be solved, it needs focused and sustained attention from our state officials. Yet, as this problem was growing in Ohio, the Attorney General, who now is the Republican

candidate for governor, was often absent from Ohio while he toured the USA promoting the Republican agenda. It is nothing short of ironic that he stands accused of intervening in complaints of sexual harassment made against his friends and political allies here in Ohio.

These are just a few examples of the many instances of corruption, negligence, and disregard for human worth and dignity during recent years of Ohio Republican rule. It is past time to restore decency to Ohio's government and to Ohio's citizens. This can only be accomplished by electing new leaders. Democrats have made a commitment to put people first. FROM THE DECLARATION OF INDEPENDENCE

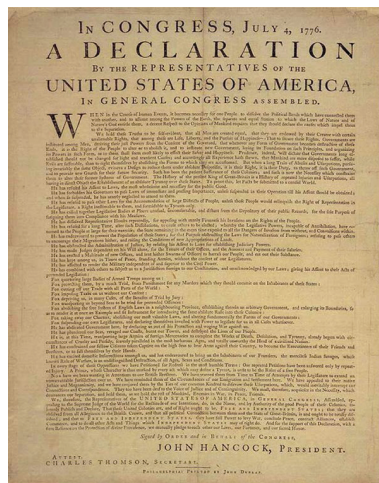
The following words were taken directly from the Declaration of Independence, adopted by 13 united states of America on July 4, 1776:

“Governments are instituted among Men, deriving their just powers from the consent of the governed ... whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it.

“The history of the present King is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these states. To prove this, let facts be submitted to a candid world:

- He has refused his Assent to Laws, the most wholesome and necessary for the public good
- He has endeavored to prevent the population of these States; for that purpose, obstructing the Laws for Naturalization of Foreigners, refusing to pass

- others to encourage their migrations hither
- He has erected a multitude of New Offices, and sent hither swarms of Officers to harass our people, and eat out their substance
- He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws
- [He has] cut off our trade with all parts of the world
- He has excited domestic insurrections amongst us
- Our repeated Petitions have been answered only by repeated injury. A Prince, whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people”



As these words ring true once again, let us use our hard-won freedoms and elect individuals who will support and uphold our inalienable rights. ❖

I picked her up at her home in West Union and we went for breakfast. She was greeted by everyone in the restaurant. We talked about a woman who ran for local office many years ago and she provided me with information to write an article on the story. Now, I wish it were Valerie I'd interviewed for an article. She was unique – and a wealth of information.

There are many things about Valerie that are widely known. She never married and she lived all her life with her mother and grandmother in their family home. She worked in several businesses locally and retired from the Post Office. She was a lifelong member of the Methodist Church in West Union. Her special avocation was

genealogy. And as I was told, she was widely regarded as someone who was always willing to help.

She was described as being something of a private detective who used genealogical research to help people connect up. Her democratic ideals and independent nature led her to attend several inaugurations in Washington D.C. It was important to her that people understand and recognize how fragile and precious human life is. She researched and wrote articles on the cholera epidemic in Adams County in which many citizens sickened in late morning died by sundown. Her personal history pointed to her remarkable courage and independence from an early age. For instance, in high school, in the early forties, she stood up for a teacher who was not rehired. She marched with her fellow students to courthouse square – with signs on tobacco sticks!

Valerie was a unique blessing to Adams County. She died at 92 years old. She is missed. Her courage and independence are greatly needed at this time and in this place. I am confident,

had she lived and been physically well enough, she would have stood up to the growing madness, and accompanied those of us who protest racism and sexism and xenophobia – in our pussy hats. In fact, I think she would have documented the history of these hats – for posterity. ❖

Ohio Issue 1

Ohio Issue 1, known as the Drug and Criminal Justice Policies initiative, will be the only statewide issue on the ballot on November 6, 2018. Issue 1 is a proposed constitutional amendment which would:

- make offenses related to drug possession and use no more than misdemeanors;
- prohibit courts from ordering persons on probation for felonies be sent to prison for non-criminal probation violations;
- create a sentence credits program for inmates' participation in rehabilitative, work, or educational programs; and
- require the state to spend savings due to a reduction of inmates, resulting from Issue 1, on drug treatment, crime victim, and rehabilitation programs.

It is clearly stated that this ballot initiative would not be applied to individuals convicted of murder, rape, or child molestation.

Supporters stress that Issue 1 will save taxpayer dollars, put public safety money to better use, reduce recidivism, and promote public safety. Detractors believe that policies of this sort should be set by Ohio's General Assembly and that passage of the issue might indicate to children that drugs are not dangerous.

A number of judges, some prosecuting attorneys, some law enforcement agencies, and the Ohio Crime Victim Justice Center oppose Issue 1. Mental health and addiction treatment providers, some faith leaders, some law enforcement officers, some victims, and the Ohio Justice Policy Center support the issue. ❖

What is the court of appeals? There are twelve appellate districts established by the Ohio Constitution. The number of judges in each district depends on caseload and the size of the district. The number of judges varies from four to twelve and the Fourth District Court of Appeals has 4 judges and is comprised of fourteen counties. The primary function of the appellate court is to hear appeals from the common pleas, municipal and county courts and each case is heard and decided by a three-judge panel.

Appellate judges are elected in even-numbered years to six-year terms on a nonpartisan ballot and must be attorneys with at least six years of experience in the practice of law.

Judge Marie Hoover is running for reelection to the Ohio 4th District Court of Appeals. Judge Hoover was elected by the court as the Presiding and Administrative Judge. 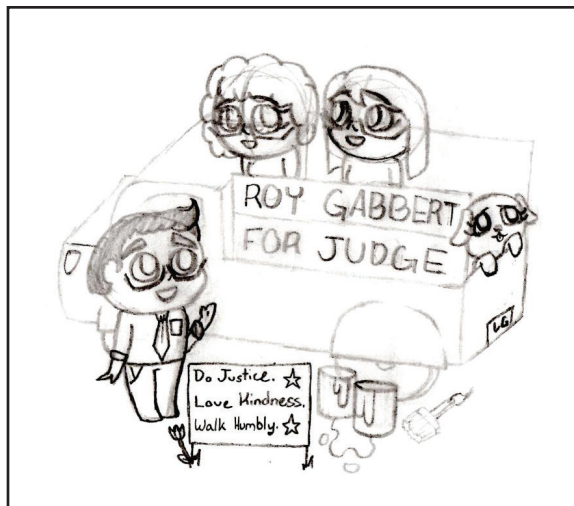
