ay 8, 2018 is the Primary Election and you can choose from among many Democratic candidates who can then run in November. In order to vote in the Primary you must be registered, and the last day to register is April 9th. Early voting begins on April 10th.

If you think your one vote doesn't matter, consider what the outcome would have been if our founding fathers felt that way. Throughout history people have fought and died for your right to vote. People like you and me do make a difference by voting because

we choose people who will work for our priorities, priorities such as affordable health care, education, a living wage and the health of our planet. You can choose to matter and to make a difference by voting and nothing stands in your way.

Between now and the time you vote, it

is important to study the candidates as there are several contested races. Among the contested races in the Democratic Primary are Governor, 2nd Congressional, 90th State Representative, and male member of Democratic State Executive Committee.

We give you information on the candidates at all levels including judicial candidates. We provide websites where you can do more in-depth research to help you be an informed voter. We also summarize a statewide ballot issue proposing redistricting reform.

The focus of this edition is on the Primary Election with a few other articles that impact our state or are of interest locally. Read True Blue and share it! Study the issues and candidates further and give us feedback and suggestions for future editions. And please be sure to vote in the Primary!

Vote for Issue 1

Last fall more than 2,000 volunteers collected over 200,000 signatures of registered Ohio voters who were willing to support a bipartisan amendment to Ohio's Constitution. They were part of a group known as the "Fair Districts = Fair Elections Coalition," which was backed by both the League of Women Voters and Common Cause. As a result of this grassroots campaign, members of Ohio's General Assembly worked together to come up with their own constitutional amendment, which will appear on the ballot in this May's primary election as Issue 1.

According to state Democratic Chair David Pepper, Ohio's current Congressional districts are

the result of "the worst gerrymandered map in the history of the state." Many political pundits have stated that once that map was drawn after the 2010 census, Republicans have been virtually "guaranteed" to win all but two of Ohio's seats in the U.S. Congress.

Issue 1 is an attempt to remedy the current situation. If voters decide to pass Issue 1, it stipulates that when a new map is drawn after the 2020 census, 3/5ths of both houses of the General Assembly (including at least 50% of whichever is the minority party) must be willing to accept the redistricting plan. If this cannot be achieved, then drawing a "fair" map becomes the responsibility

of a 7-member Redistricting Committee (where at least 2 votes from whichever is the minority party must be cast in favor of the plan).

There are two other methods established as "fall backs," in case the Redistricting Committee should fail in its attempt to draw a new map. Moreover, Issue 1 contains several specific provisions that will limit the number and ways

in which counties and other communities can be "split."

Volunteers for Fair Districts Ohio plan to continue collecting signatures for their ballot initiative until after Issue 1 has actually passed. This is seen as a way to keep politicians' "feet to the fire." Issue 1 has been endorsed by the Ohio Democratic Party, whose Chair has observed that, "When the people really rise up, elected officials must respond."

Sherrod Brown for United States Senate, Representing Ohio



"Washington bailed out Wall Street, and Wall Street turned around and stole pensions [that] Ohioans worked for...Congress has responsibility to protect the pensions workers earned before it is too late." – Sherrod Brown

Many Adams County residents have met Sherrod Brown and know that he is friendly, knowledgeable, and willing to fight for their rights. Most can share a positive anecdote concerning his record of service – first, as Ohio Secretary of State, then as a member of the U.S. Congress, and most recently as a member of the U.S. Senate.

Sherrod has championed issues such as fair trade policies (before the notion became popular), opposing efforts to export food jobs to other countries (remember, Sherrod once joined Ted Strickland in the U.S. House to vote against NAFTA), and advocating consistently for middle class issues (in the face of Big Money opposition, such as the Koch brothers).

Sherrod Brown succeeded in introducing 120 bipartisan bills in the Senate in 2017. Similarly, he led members to stand up to our geopolitical adversaries. But, throughout it all, Sherrod stays in the limelight and on the cutting edge of issues important to middle class Ohioans. He supported the empowerment of border agents to identify and apprehend fentanyl smugglers, and fought to protect pensions that Ohioans have earned. (He now serves as Co-chair of the Joint Select Committee on Pensions).

Sherrod Brown has been endorsed by the Ohio Democrat Party and deserves to be reelected.

A Look Beyond the Name... William R. Smith has name recognition because he was on the ballot in 2012, 2014, and 2016. This year he is once again running as a Democratic candidate for the 2nd Congressional District. In each previous cycle, Mr. Smith mounted no campaign and has never attended any Democratic function in Adams County. His past lack of effort demonstrates he is not an electable standard-bearer for the Democratic Party in a General Election. You know his name and now you know more than his name. ❖

Ohio's Online Charter School Fiasco


Charter schools in Ohio are one of the many privatization initiatives which divert taxpayer money away from Ohio public schools. Some of these charter schools are actual school buildings, while some are internet-based, online programs.

Educational outcomes from Ohio's charter schools are a growing concern to the citizens of our state; all too often, the money invested to educate students has wound up lining the pockets of the schools' founders. The story here is continuing to unfold.

In Adams County, there are no building-based charter schools. But, internet-based, online charter schools have been very active and have impacted our schools and our communities. These privately owned, charter schools take taxpayer monies away from local school districts while promising to educate the students enrolled in them. Yet, in too many cases, these charter schools are not meeting their basic obligations. In one case, the charter school suddenly closed down midyear, literally leaving all of its students educationally stranded.

Administrators from Adams County/Ohio Valley Local Schools and the Manchester Local School District report that Adams County taxpayers sent nearly \$700,000 to online charter schools to pay for Adams County students enrolled in online educational programs during the 2016-17 school year. Yet, according to data collected by the state during that same time period, online institutions receiving these monies too often failed to even keep track of the Ohio students they were paid to educate.

Adams County/Ohio Valley Local Schools and Manchester Local School District also report our county had a total of 55 students enrolled in the largest of these online schools, the Electronic Classroom of Tomorrow (ECOT), during the 2016-2017 school year. After ECOT was sued by the Ohio Department of Education for failing to provide basic records on these students, ECOT suddenly closed down in January, 2018. This caused significant disruption to the educations of these students. Students, their families, and their **Ohio's** home school districts were suddenly faced with the challenge of seeking and finding other, appropriate

school programs for these students during the middle of the school year.

When ECOT closed in January 2018, approximately 12,000 students from throughout the state were enrolled in its program. These students, from throughout Ohio, were suddenly left "high and dry," needing to find appropriate school settings in the middle of the school year in order to continue their educations.

Local public schools and teachers are continuously being evaluated and asked to demonstrate improved student performance and favorable educational outcomes. However, according to state-collected data from the 2016-2017 school year, "every penny sent from a school district to ECOT...came from a district that outperformed the online giant by at least four out of thirteen state report card categories. And an astonishing one out of every four

dollars sent to ECOT came from a district that outperformed ECOT on every comparable measure" (Stephen Dyer, "Innovation Ohio," 2/2/18).

Millions of dollars of taxpayer monies have been diverted to ECOT, and to many other charter schools, over the past two decades. Because ECOT's educational outcomes have been less than had been promised, the state is attempting to recover some of these funds. It is not known how successful these recovery efforts will be. And, it could be argued that the state has some culpability here, as the state contracted with ECOT and the state was responsible to provide oversight. More information is likely to be forthcoming in the future regarding resources that have been entrusted to charter school programs. We will attempt to provide an update on this important matter to True Blue's readers in our fall issue. �

Democratic Candidates for Governor on the Primary Ballot

The Ohio Democratic Party (ODP) has not endorsed a candidate for Governor in the Primary and believes an open Primary is good for democracy. There will be six Democratic candidates for Governor on the ballot. Nan Whaley, Mayor of Dayton and Connie Pillich, former State Representative both withdrew and have endorsed Richard Cordray. Though ODP has not endorsed, four of the candidates were vetted by an ODP committee and are approved to participate in ODP Candidate Debates & Town Hall Forums.

Democratic Candidates for the Ohio Supreme Court emocratic TENDORSED



The success of American democracy is dependent on the concepts of separation of powers and of **L** each branch of government providing a check on one another. In the upcoming primary election, the executive and legislative branches will receive maximum coverage, but in this election season the Ohio supreme court will have openings that the electorate will decide. Democrats have put forth two candidates that can add expertise and diversity to the decisions confronting the court. Both are endorsed by the Ohio Democratic Party.

Judge Michael P. Donnelly



Michael P. Donnelly was elected in 2016 for the second time to the Cuyahoga County Common Pleas Court. Judge Donnelly has impressive credentials for the position. He received his law degree from John Carroll University and his law degree from Cleveland State University's

Cleveland-Marshall College of Law. After being admitted to the Ohio bar in 1992, he served five years as Assistant Cuyahoga County Prosecutor. After this position judge Donnelly worked in private practice for seven years before he was elected to the common Pleas bench. During this time period he was appointed by Ohio Supreme Court to the Commission on Professionalism from 2007-12. He served on Ohio State Board of Examiners and on the Ohio Jury Instructions Committee. Also, Judge Donnelly has been involved and serves on board of the Cleveland Baseball Federation which is one of Cleveland's oldest charitable organizations helping Cleveland's children play ball in the summer at no charge.

An important question to contemplate when considering a candidate is why is the candidate seeking this position and what policies will he be working towards. Let us quote Judge Donnelly: "I love being a trial court judge because it offers me the opportunity to use the law to help people resolve disputes. This ability of our courts makes them an indispensable backbone of our society. . . I believe that to ensure the public's confidence in our courts, we must be as transparent as possible and give the public the chance to discern that disputes are being resolved fairly through an open and efficient process. . . As a Justice of the Ohio Supreme Court,

I will . . . provide all citizens with the opportunity to access the courts for dispute resolution and ensure that justice is neither delayed nor denied."

The Supreme Court of Ohio is a critical component in the governing of Ohio. With all the present seats fulfilled by the Republican Party, a countervailing voice is required. Your participation and vote is critical. ❖

Judge Melody J. Stewart



Judge Melody J. Stewart is currently serving in the Ohio Court of Appeals in the Eighth Appellate District, Cuyahoga County. She has twice been reelected to this position (in 2010 and 2016) and is a candidate in the November 2018 election for a seat on the Ohio Supreme Court.

Judge Stewart earned her law degree from the Cleveland-Marshall College of Law, Cleveland State University, and has completed her Ph.D. at Case Western Reserve University's Mandel School of Applied Social Sciences. Ms. Stewart is also a graduate of the College-Conservatory of Music at the University of Cincinnati.

Judge Stewart will bring 30 years of life/ work experience to the Ohio Supreme Court. She has worked in the health care industry, as a music educator, a non-criminal trial lawyer, an assistant dean at the Cleveland-Marshal College of Law and also as a professor at the Cleveland-Marshall College of Law, in addition to her years of service on the Ohio Court of Appeals.

We very much need a Democratic voice on the Ohio Supreme Court. (Presently, all seven seats are held by Republicans.) Judge Melody J. Stewart can be that voice. .

the postal mailing list and mailed and emailed True Blue.


